He thought we could keep our same tax-free number by notifying State of change but we should check with lawyer (City) before doing it.
- 2. Check with the City on naming rights. Since the city is kicking in \$500,000 then the naming should go to someone who will give at least than much.
- 3. Get your fund raising info materials ready and in hand before talking to donors. Establish levels of contribution and include this in your materials. Plan a permanent display of this at the new pool.
- 4. The City and the School District are already lead donors but work to get an individual or business on board as a lead donor as soon as possible. He suggested contacting Mary Laschinger. CEO of Veritiv Corporation (an Arkansaw native and Durand HS Graduate). Bill Berger is the one who

contacted her on the football field project. Larry thought we should talk to Bill before we try to get in touch with her.

- First target for your campaign should be the group of people/businesses/organizations who are capable of giving large donations (\$5000+). Brainstorm who this group is and organize your people to make the contacts. Make these donations known as they come in to create a snowball effect.
